Submitting a thesis by compilation requires approval from the Delegated Authority (in Crawford's case, the HDR Director), as per section 16 of the ANU's Procedure: Higher degree by research -- thesis by compilation and thesis by creative works. Students wishing to submit a thesis by compilation should discuss this with their supervisor at an early stage in their candidature and must notify and obtain the endorsement of their panel least 12 months prior to submission, and no later than 6 months prior to submission. The approval process ensures that the student has received important, discipline-specific guidance on the appropriate quantity and quality of papers for submission as a thesis.
